**SUPPLEMENTAL DECLARATION OF COVENANTS
AND RESTRICTIONS FOR KINDLEWOOD**

THIS SUPPLEMENTAL DECLARATION is made this 16 day of February, 2024 by
D.R. HORTON, INC. – JACKSONVILLE, a Delaware corporation (“*Declarant*”) who recites and provides:

RECITALS:

A. Declarant subjected certain lands to the terms and conditions of that certain Declaration of Covenants and Restrictions for Kindewood, recorded in Official Records Book 4738, page 1770 of the public records of Clay County, Florida (the “*Declaration*”).

B. Pursuant to Article IV, Section 2 of the Declaration, Declarant is authorized to subject other lands to the terms and conditions of the Declaration by recording a Supplemental Declaration.

C. Declarant is the owner of certain lands more particularly described as follows (the “*Additional Lands*”):

NOW, THEREFORE, in consideration of the premises Declarant hereby declares:

1. All Recitals are true and correct.
2. The Additional Property is hereby subjected to all terms and conditions of the Declaration and all owners of all or any portion of the Additional Property shall be bound by all such terms and conditions and shall have all rights and obligations set forth herein. The Additional Property shall be held, transferred, conveyed and encumbered in compliance with the terms and conditions of the Declaration, which are covenants running with title to the Additional Property.
3. Except as set forth herein, all terms and conditions of the Declaration remain in full force and effect.
