**AMENDMENT TO DECLARATION OF COVENANTS,
CONDITIONS, RESTRICTIONS AND EASEMENTS
FOR TUSCANY GLEN**

This is an amendment to the certain Declaration of Covenants, Conditions, Restrictions and Easements for Tuscany Glen, (hereinafter referred to as the Amendment).

RECITALS:

- A. Developer has recorded the Declaration of Covenants, Conditions, Restrictions and Easements for Tuscany Glen and the Declaration affects the property known as Tuscany Glen recorded in Plat Book 48, pages 40 through 42 inclusive of the public records of Clay County, Florida.
- B. Said Declarations are recorded in Official Records Book 2734, page 691 of the public records of Clay County, Florida.
- C. Developer reserved the right within those Declarations of Covenants, Conditions, Restrictions and Easements for Tuscany Glen to amend the Declaration of Covenants, Conditions, Restrictions and Easements for Tuscany Glen.

DECLARATION

NOW THEREFORE, Developer amends the Declaration of Covenants, Conditions, Restrictions, and Easements for Tuscany Glen, and as amended, as follows:

Add to Article VIII. Section 14. No Parking of Vehicles, Boats, Etc.:

There shall be no parking of vehicles or equipment on the roadways or streets. Any request for temporary street parking must be granted in advance by the Homeowners Association.

Add to Article VIII:


Section 22. Basketball Goals. No portable basketball goals shall be allowed in any of the front yards of any homes. Permanent basketball goals may be allowed provided it is located at least 20 feet from the street curb and all plans must be submitted and receive architectural review board approval before installation.
