2) NEITHER THE LAKES AND FILTRATION SYSTEMS SHOWN ON THIS PLAT, NOR TRACT "C", ARE DEDICATED TO CLAY COUNTY HEREBY. 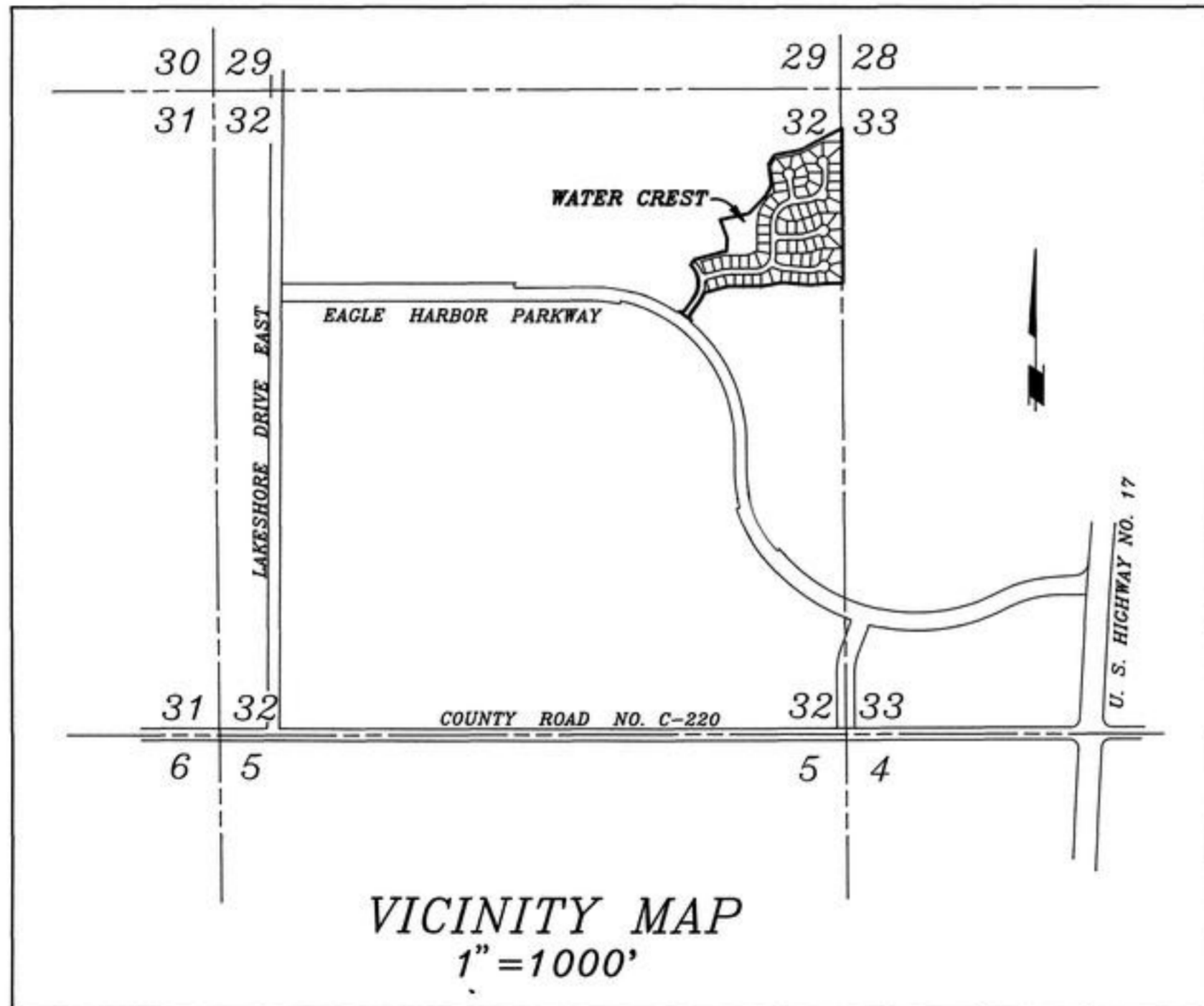

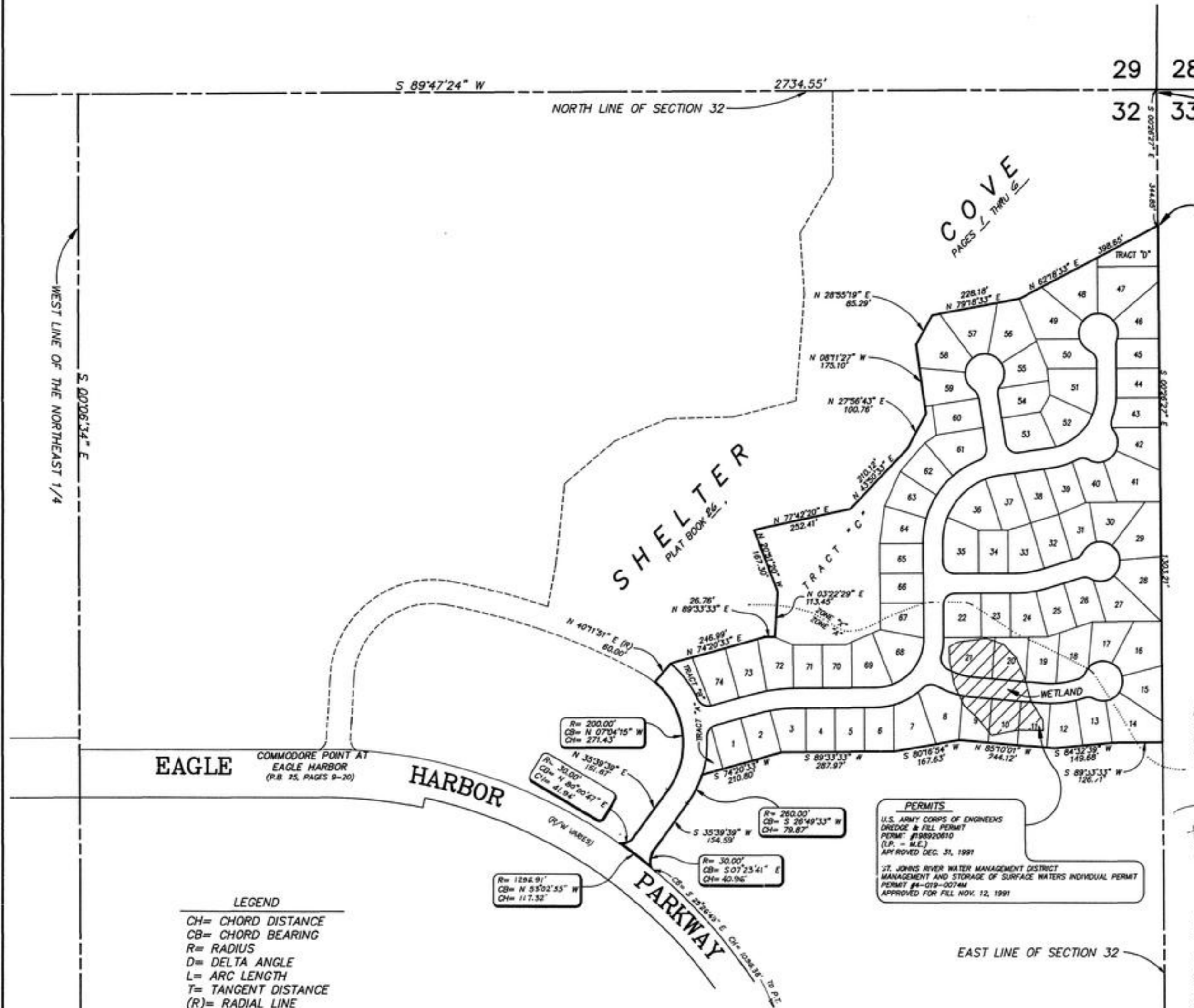
