**AMENDMENT TO MASTER DECLARATION OF COVENANTS AND
RESTRICTIONS**

This Amendment to Master Declaration of Covenants and Restrictions (this "Amendment") is made this 10th day of September, 2019, by **CAMPFIELD COMMONS OWNERS ASSOCIATION, INC.**, a Florida not-for-profit corporation (the "Association").

W I T N E S S E T H

WHEREAS, Wiley James, LLC established that certain Master Declaration of Covenants and Restrictions dated as of January 16, 2014, and recorded in Official Records Book 16663, page 2082, of the public records of Duval County, Florida (the "Declaration"); and

WHEREAS, the Board of Directors of the Association wishes to modify the Declaration upon the terms and conditions set forth in this Amendment to provide that the definition of "Common Areas" is inclusive of property designated as "Common Areas" in any Supplementary Declaration permitted pursuant to Section 2.3 of the Declaration.

NOW, THEREFORE, the Association hereby declares as follows:

1. The foregoing recitals are true and correct, and are incorporated herein by this reference.
2. Except as expressly set forth in this Amendment, all capitalized terms which are used but not defined in this Amendment shall have the meanings ascribed to them in the Declaration.
3. Section 1.7 of the Declaration is hereby deleted, amended and restated in its entirety as follows:

1.7 "Commons Areas" means the non-exclusive and perpetual easement for ingress, egress and utilities created in Section 5.1 hereunder and located over, upon and across the lands depicted on **Exhibit B** attached hereto as "Interior Road", which lands are more particularly described on **Exhibit B-1** attached hereto, together with any other property designated as Common Areas in this Declaration or any Supplementary Declaration pursuant to

Section 2.3 of this Declaration. When and if constructed the term Common Areas shall also include the roadway, curbs, sidewalks, light posts and stormwater piping that may be constructed within the easement area by or at the direction of the Sponsor or the Association and the replacements and repairs thereto that may be made from time to time.

4. Except as expressly modified herein, the Declaration is hereby ratified and confirmed, and shall remain in full force and effect. In the event of any conflict between the provisions of the Declaration and the provisions of this Amendment, the provisions of this Amendment shall supersede and prevail.
