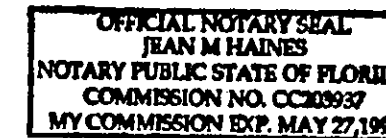

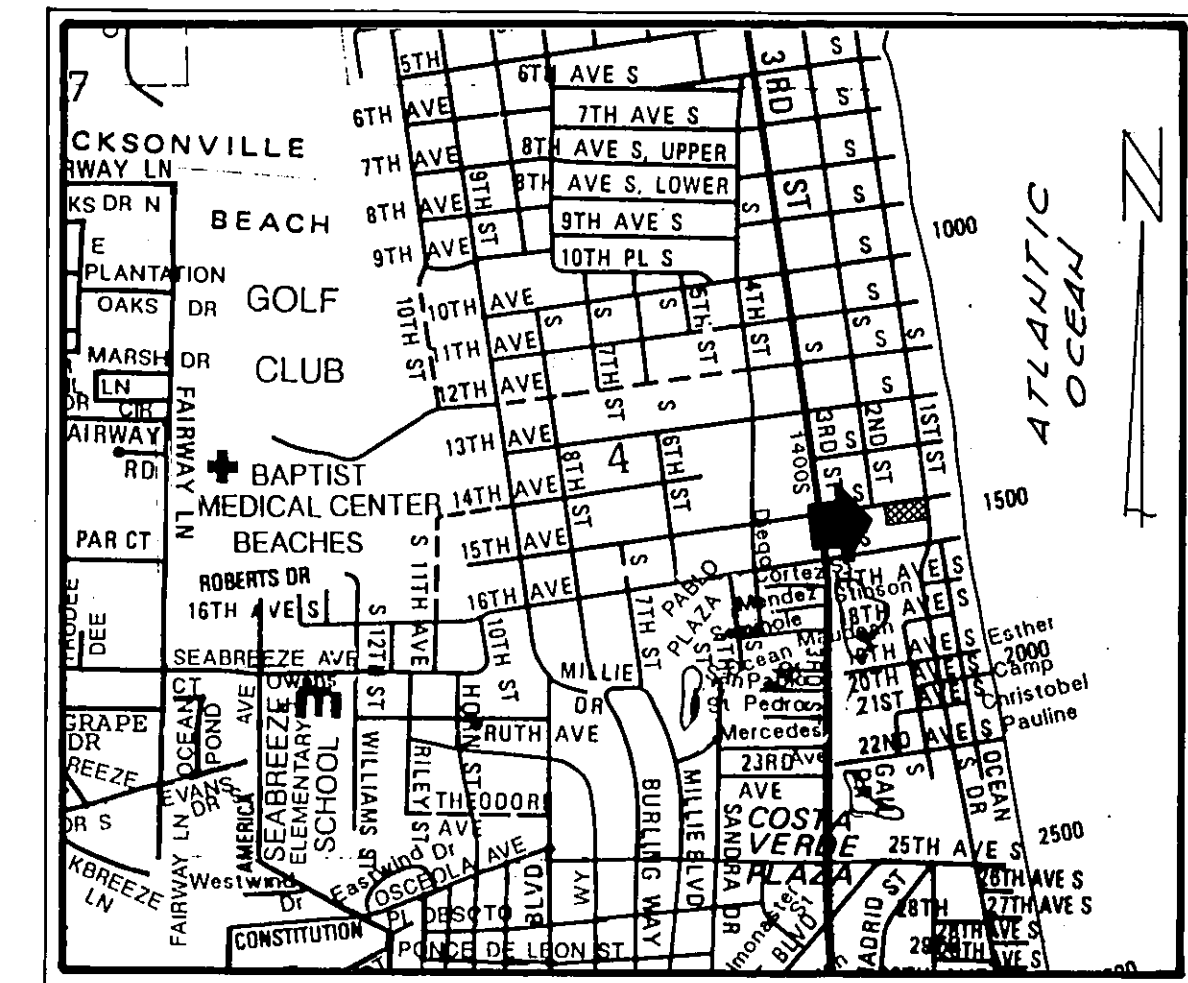

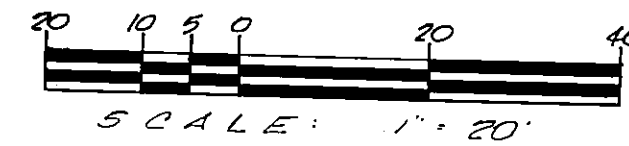
VICINITY MAP

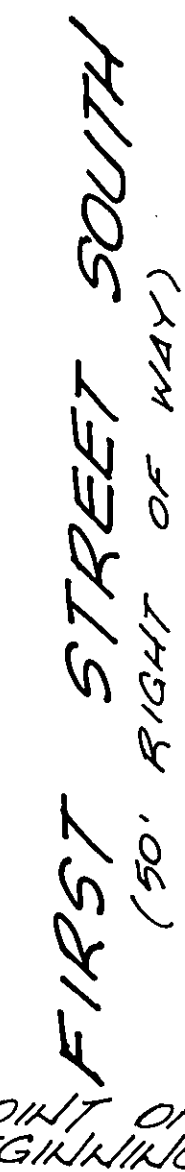
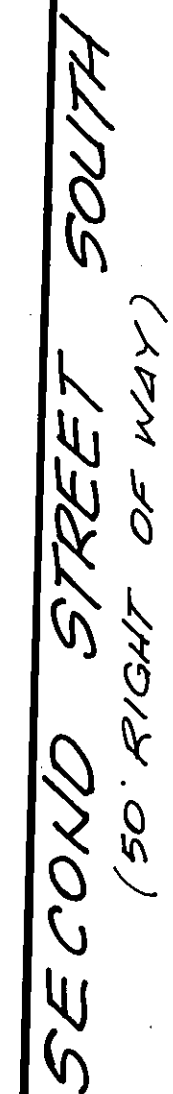
