**SUPPLEMENTAL DECLARATION TO DECLARATION OF
COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS
FOR LONGLEAF**

THIS SUPPLEMENTAL DECLARATION is made on October 9, 2014
by LENNAR HOMES, LLC, a Florida limited liability company ("Developer").

RECITALS

A. Developer subjected certain lands owned by it to the Declaration of Covenants, Conditions, Restrictions and Easements for Longleaf as recorded on June 12, 2014 in Official Records Book 16809, page 1805, of the public records of Duval County, Florida (the "Declaration").

B. Pursuant to Section 14.6 of the Declaration, the Declaration may be amended at any time upon the execution and recordation of an instrument executed by the Developer, for so long as the Developer holds title to any Lot; provided however that any such amendment shall not (i) be inconsistent with the general scheme of development within Longleaf or (ii) materially and adversely alter the proportionate voting interest appurtenant to a Lot or increase the proportion or percentage by which a Lot shares in the common expenses of the Association, as defined in the Declaration.

C. The Developer desires to amend the Declaration to provide notice that individual lots may be located in an airfield environ.

D. The provision of such notice is not inconsistent with the general scheme of development within Longleaf and does not alter the voting interest appurtenant to a Lot and does not alter the proportion or percentage by which a Lot shares in the common expenses of the Association.

NOW THEREFORE, Developer hereby declares as follows:

1) Section 14.20 is added to the Declaration as follows:

14.20 Air Installation Compatible Use Zone.

Individual lots may be located in an airfield environ (Air Installation Compatible use zone " **AICUZ** ") and may be subject to increased noise levels associated with air traffic operations.

2) Except as modified and supplemented herein, the terms and conditions of the Declaration remain in full force and effect.
