**AMENDMENT TO DECLARATION OF CONDOMINIUM FOR
OCEANS EDGE CONDOMINIUM**

The following amendments are made to Article 8 and Article 15 of the DECLARATION OF CONDOMINIUM FOR OCEANS EDGE CONDOMINIUM, recorded in Official Records Book 13489, Page 953, *et. seq.*, as amended from time to time, of the Public Records of Duval County, Florida (additions are indicated by underlining, deletions are indicated by ~~striketrough~~, and omitted but unaltered provisions are indicated by ellipses):

**ARTICLE 8
COMMON EXPENSES**

...

~~K. Working Capital Fund/Capital Contribution Assessment. The Developer will cause to be collected from the initial purchaser of a Unit a fee equivalent to two month's maintenance for said Unit, except such fee shall not be due in connection with a sale of Units to a successor Developer, but such successor Developer shall collect the same at the time it sells each such Unit. These monies will be turned over to the Association within sixty (60) days after the closing of the sale of the Unit and used (i) for unforeseen capital expenditures or (ii) to purchase additional equipment or services or (iii) for maintenance cost overruns once the Developer no longer guarantees the monthly assessments. Regardless of any other provision within the Association's governing documents, including this Declaration, upon any sale or transfer of title of any nature of any Unit within the Condominium, there is hereby established against said Unit a single assessment in an amount equal to two months' maintenance assessment(s) applicable to said Unit (as of the date of transfer of title), which is due and payable to the Association upon the date of recording of the deed or other instrument conveying said Unit (hereinafter: "Capital Contribution Assessment"). This Capital Contribution Assessment may be enforced against the Unit and/or Owner in the manner specified for other assessments within this Declaration, including, but not limited to, the Association having the right to impose and foreclose a lien upon the respective Unit for non-payment of this Capital Contribution Assessment, and the recovery of costs and reasonable attorney fees incurred in collecting this Capital Contribution Assessment and/or preparing or foreclosing the lien for this Capital Contribution Assessment. As such, this Capital Contribution Assessment may be enforced against the Owner taking title to the Unit on the date such Capital Contribution Assessment is due and payable, or any Owner taking title to the Unit at any time thereafter. This Capital Contribution Assessment is in addition to any and all other assessments specified within this Declaration. The Association may use the funds received from such Capital Contribution Assessment in any manner as determined by the Board of Directors.~~

**ARTICLE 15
MAINTENANCE, REPAIRS AND REPLACEMENT**

A. By the Association. The Association shall maintain, repair and replace at the Association's expense:

1. All Common Elements including, but not limited to, all roofs and all Limited Common Elements, except: (i) Unit Owners shall maintain the air conditioner condenser for his/her Unit; and (ii) Unit Owners shall be responsible for general cleaning and housekeeping of Limited Common Elements appurtenant to his/her Units.

2. All portions of a Unit contributing to the support of the Unit except interior surfaces, which portions shall include but not be limited to load-bearing columns and load-bearing walls, but shall not include screening, windows, storms shutters, entrance doors, glass and interior surfaces of walls, ceilings and floors.

3. All conduits, ducts, plumbing, wiring, air conditioning pipes and other facilities for the furnishing of utility services, including air conditioning, contained in the portions of a Unit that service a part of the Condominium Property or a Unit other than the Unit within which contained.

4. All incidental actual damage(s) caused to a Condominium Unit by reason of maintenance, repair and replacement accomplished pursuant to the provisions of Article 15 (A) (1), (2), and (3) above, and any incidental damages caused to a Condominium Unit by reason of maintenance, repair and replacement accomplished pursuant to the provisions of Article 15 (A) (1), (2), and (3) above, not otherwise covered by any insurance which has been procured by a Unit Owner covering any such Owner's Condominium Unit. If any Condominium Unit, damaged by reason of maintenance, repair and replacement accomplished pursuant to the provisions of Article 15 (A) (1), (2), and (3) above, is not covered by any insurance which could have otherwise been procured by a Unit Owner over any such Owner's Condominium Unit (but was not actually procured by said Unit Owner), the Association's maintenance, repair and replacement responsibility as to the damaged Condominium Unit shall be limited only to actual damages to such Condominium Unit. Notwithstanding anything contained herein to the contrary, any responsibility of the Association for maintenance, repair and replacement of any actual or incidental damages to a Condominium Unit by reason of maintenance, repair and replacement accomplished pursuant to the provisions of Article 15 (A) (1), (2), and (3) above shall be limited to the extent that any such actual or incidental damages are covered by any insurance procured by a Unit Owner over any such Owner's Condominium Unit.

B. By the Unit Owner. The responsibility of the Condominium Unit Owner for maintenance, repair and replacement shall be as follows:

...


4. To promptly report to the Association any defect or need for repairs for which the Association is responsible. For purposes of this section, "promptly report" shall require the Unit Owner to report to the Association any such defect or need for repairs within forty-eight (48) hours of discovery by the Unit Owner of any such defect or need for repairs. If any Unit Owner should fail to promptly report any defect or need for repairs for which the Association is responsible, the Unit Owner shall have full responsibility for payment for the costs for maintenance, repair and replacement necessary to correct any such defect or need for repairs, regardless of any other provision within any of the Association's governing documents to the contrary. Should any such Unit Owner fail to pay for the costs of any such maintenance, repair and replacement necessary to correct any such defect or need for repairs within 15 days of the date of demand by the Association for payment thereof, the Association may treat such demand as a Special Assessment against such Unit Owner, collectable in accordance with any of the Association's governing documents, including the Association's Declaration and Bylaws, as same may be amended from time to time.

6. To physically inspect, or cause the physical inspection by a representative of the Unit Owner of, the condition of any unoccupied Unit at a minimum of one instance in each fourteen (14) consecutive day period. For purposes of this section, "unoccupied" shall refer to any Unit that does not have any individual physically present in such Unit for at least one (1) hour in any 72 consecutive-hour period. If any Unit Owner, or his or her representative, should fail to inspect any unoccupied Unit owned by the Unit Owner in accordance with this section, the Unit Owner shall have full responsibility for payment for the costs for maintenance, repair and replacement necessary to correct any defect or need for repairs, whether to the Unit or to the Common Elements, regardless of any other provision within any of the Association's governing documents to the contrary. Should any such Unit Owner fail to pay for the costs of any such maintenance, repair and replacement necessary to correct any such defect or need for repairs within 15 days of the date of demand by the Association for payment thereof, the Association may treat such demand as a Special Assessment against such Unit Owner, collectable in accordance with any of the Association's governing documents, including the Association's Declaration and Bylaws, as same may be amended from time to time.
