**THIRD AMENDMENT TO DECLARATION OF  
COVENANTS AND RESTRICTIONS FOR SILVERLEAF MASTER**

THIS THIRD AMENDMENT TO DECLARATION OF COVENANTS AND RESTRICTIONS FOR SILVERLEAF MASTER ("Third Amendment") is made effective December 3, 2019, by WHITE'S FORD TIMBER, LLC, a Florida limited liability company (the "Declarant").

**RECITALS:**

A. The Declarant has previously executed and recorded the Declaration of Covenants and Restrictions for Silverleaf Master recorded in Official Records Book 4743, at page 1063, which has been amended in Official Records Book 4755, at page 1180, and in Official Records Book 4813, all of the public records of St. Johns County, Florida records (together, the "Declaration").

B. The Declarant desires to amend the Declaration as more particularly described below and this Third Amendment is made pursuant to the reserved rights of the Declarant set forth in Section 12.7 of the Declaration. The amendment to the Declaration effected hereby does not materially and adversely affect the value of any Lot or other building parcel located within the Property.

**NOW THEREFORE**, the Declarant hereby amends the Declaration as follows:

1. The Declarant confirms that the above stated recitals are true and correct. All capitalized terms contained in this Third Amendment shall have the same meanings as such terms are defined in the Declaration.

2. Section 5.5 of the Declaration is hereby amended in its entirety as follows:

Capital contributions collected pursuant to this Section 5.5 may be used for any purpose reasonably contemplated by this Declaration or the Association's Articles of Incorporation or Bylaws, as determined in the reasonable discretion of the Association's Board of Directors.

Capital contributions collected pursuant to this Section 5.5 may be used for any purpose reasonably contemplated by this Declaration or the Association’s Articles of Incorporation or Bylaws, as determined in the reasonable discretion of the Association’s Board of Directors.

3. Except as specifically amended hereby, all of the terms and provisions of the Declaration shall remain in full force and effect as originally executed.
